




# HUD'S FIELD STRUCTURE





#### U.S. Department of Housing and Urban Development San Antonio Area Office Organizational Chart






## **HUD's Grant Programs**

- Formula Funding Block Grants







## Formula Funding Flow




# **Community Development Block Grant (CDBG)**

The Community Development Block Grant (CDBG) program is a flexible program that provides communities with resources to address a wide range of unique community development needs. Beginning in 1974, the CDBG program is one of the longest continuously run programs at HUD. The CDBG program provides annual grants on a formula basis to 1209 general units of local government and States.

### CDBG – Eligible Uses

- Planning
- Non-profit capacity building
- Property acquisition
- Clearance/Demolition/Remediation
- Code enforcement
- Public infrastructure improvements
- Public facility improvements
- Public services
- Economic Development
- Housing rehabilitation single & multi-family
- Homeownership assistance

### **HOME Investment Partnerships Program**

The HOME Investment Partnerships Program (HOME) provides formula grants to States and localities that communities use - often in partnership with local nonprofit groups - to fund a wide range of activities including building, buying, and/or rehabilitating affordable housing for rent or homeownership or providing direct rental assistance to low-income people. HOME is the largest Federal block grant to state and local governments designed exclusively to create affordable housing for low-income households.

### **HOME – Eligible Uses**

- Home purchase or rehabilitation financing assistance to eligible homeowners and new homebuyers;
- Build or rehabilitate housing for rent or ownership; or for "other reasonable and necessary expenses related to the development of non-luxury housing," including site acquisition or improvement, demolition of dilapidated housing to make way for HOME-assisted development, and payment of relocation expenses.
- HOME funds maybe used to provide tenant-based rental assistance contracts of up to 2 years if such activity is consistent with their Consolidated Plan and justified under local market conditions.




• ESG provides grants to states and localities for street outreach, emergency shelter, homelessness prevention, rapid re-housing assistance, and HMIS.






